What is the Going Pro Talent Fund?

The Going PRO Talent Fund grants awards (up to \$500,000) to employers to assist in training, developing and retaining current and newly hired employees.

What is the reimbursement for the training?



Classroom/ Customized Training up to \$2,000 per person



On-the-Job Training for new employees up to \$2,000 per person



USDOL Registered Apprenticeships (first year through completion) up to \$3,500 per person

What makes Dale Carnegie Programs qualify?

Training programs funded by the Talent Fund must be short-term and fill a demonstrated talent need experienced by the employer. Training must lead to a credential for a skill that is transferable and recognized by industry. The amount requested cannot exceed \$2,000 per person.

- Classroom or customized training
- New employee On-the-Job Training (OJT), eligible with CRT
- Classroom and/or OJT Training for USDOL Registered Apprenticeship (first year through completion)

Why Should I Apply?

When approved there is granted money for your company to use for your training needs.

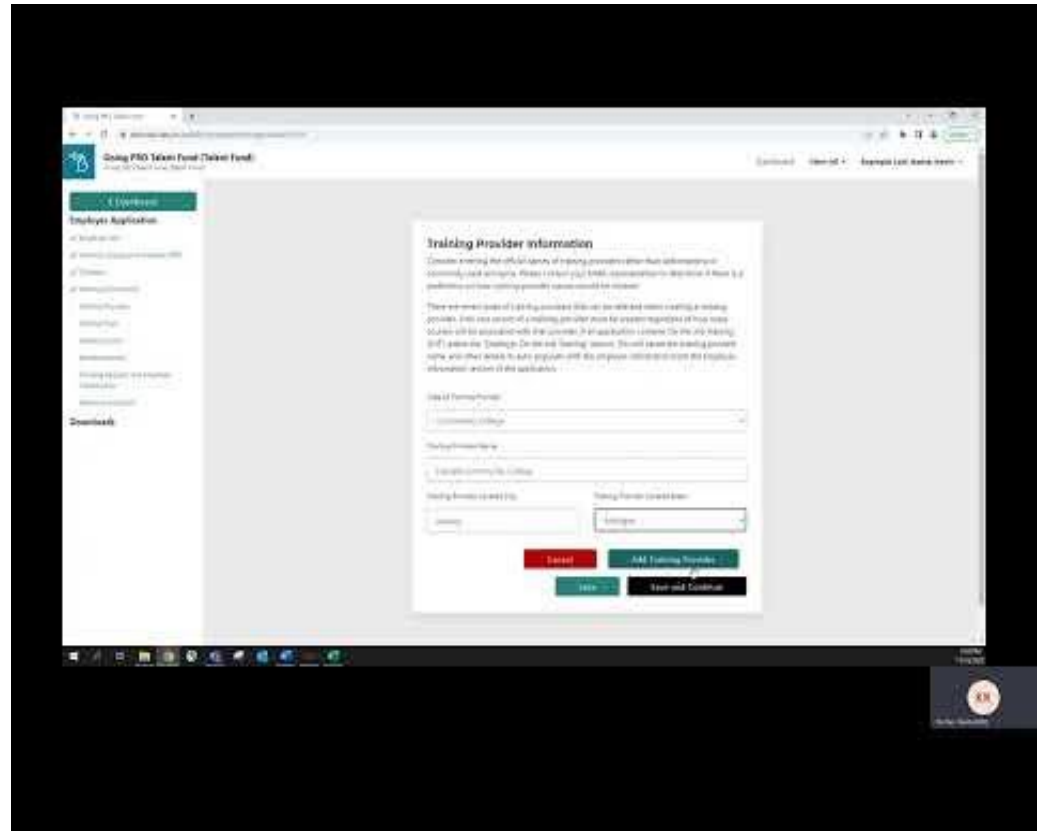
When you apply and get approved, you could take advantage of thousands of dollar's worth of training for you and your employees.

When Do I Need to Apply By?

Application Period

- The application period for the Fiscal Year 2025 Going PRO Talent Fund Cycle 1 is **now open** and will **close at 5 p.m. EDT on Friday, October 18, 2024**. Award recipients will be announced in mid-December.

Which employees are eligible to participate?

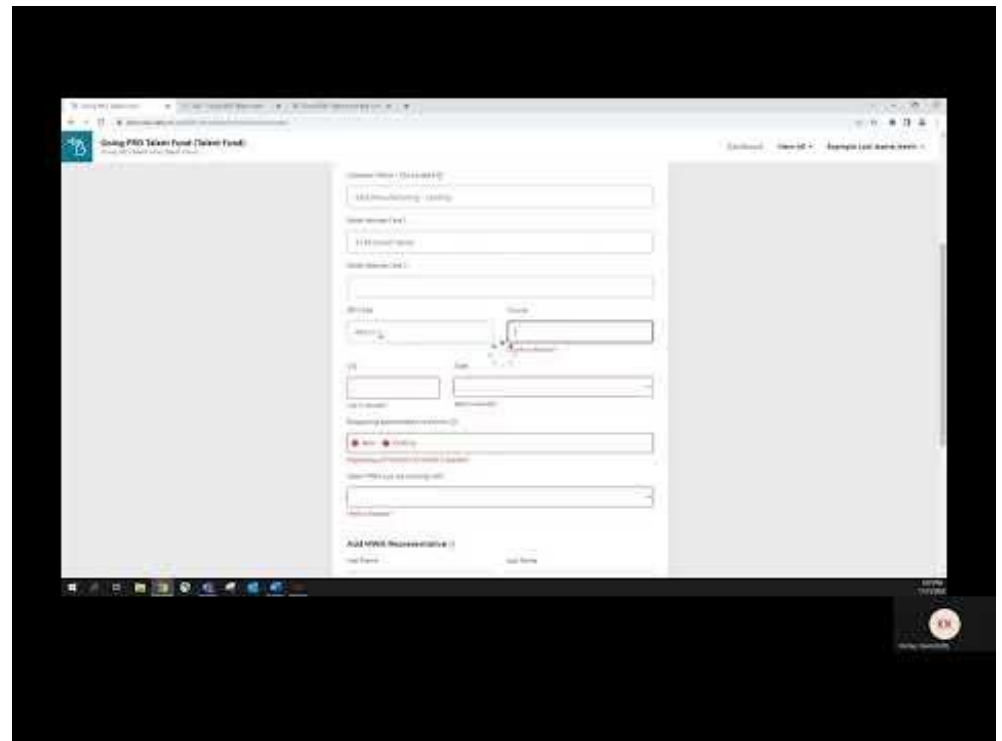
Employees, current or new, must meet each of the following criteria:

- Permanent, full-time employee of the employer when the approved training begins. If individuals have worked for the employer through a temporary staffing agency, leasing agency or on contract with a Form 1099, the individuals must be increasing their job responsibilities or learning a new job.
- Works primarily in Michigan, and for whom the employer pays all applicable taxes to the State of Michigan, regardless of where the employee lives.
- 18 years of age or older.
- Citizen or legally authorized to work in the U.S.
